Rules: Current negative Coggins and Rabies vaccination certification are mandatory and must accompany entry. The show will be run in accordance with USEA/USEF rules. Medical armbands are strongly recommended for jumping classes. All competitors must wear helmets that meet ASTM standard F1163-00 and are SEI certified. Classes may be combined, split, or canceled at the discretion of management. Dogs must be leashed. Please treat the grounds as you would your own property. Place all trash in designated containers.
