Ann and her husband Ed Iarusso have designed a musical freestyles for Pan Am Games medalists and their clients at the national levels have earned top placings at the USDF Regional Championships and the Northeast Regional Adult Amateur Championships.

Sessions will be approximately 30 minutes long for RCR and 45 min for musical lesson.

There will be 2 lectures during the day.
